

RELEASES AND LIMITATION OF LIABILITY

The traveler making this reservation agrees to accept and consent to the terms, conditions, waivers, releases and limitations of liability outlined below.

Releases: There are certain inherent risks with any form of travel, including serious bodily injury and death, as well as delays and damages to property. Abroad for Adventure, Inc., a Pennsylvania corporation (hereinafter referred to as "Abroad for Adventure"), is merely an independent agent for the various providers of travel related services to the traveler, including suppliers of accommodations, meals, transportation (ground, water and air), sports, recreational and leisure activities, entertainment and tours, and is not assuming any responsibility or liability whatsoever in connection with the services or goods provided by any of them. The traveler, for herself or himself and her or his personal representatives, heirs, successors or assigns, hereby releases Abroad for Adventure, and its officers, directors, representatives, agents, employees and shareholders, from, and agrees they are not responsible for, any and all damages, losses (including without limitation lost luggage or other belongings), death, sickness, bodily injuries, delays, changes in schedules, expenses (including without limitation medical expenses or expenses incurred as a result of delays or schedule changes) and claims of any nature whatsoever arising from or in connection with any travel related services, or other services in connection therewith, provided or arranged by Abroad for Adventure.

Actions outside of its Control: In addition to the foregoing, in no event will Abroad for Adventure be responsible for any acts of God, forces of nature, terrorism, criminal actions, labor strife, civil unrest or other actions beyond its control.

No Warranties: As described above, Abroad for Adventure is merely an independent agent for the providers of travel related services to the traveler. Abroad for Adventure makes no warranties, either express or implied, including without limitation warranties of merchantability or for a specific purpose, with respect to any such travel related provider or service.

Limitation of Liability: In addition to the releases described above, in no event whatsoever will Abroad for Adventure's liability to a traveler be greater than the amount of the fees paid by the traveler to Abroad for Adventure for the trip related to any such claim, notwithstanding that the amount of damages suffered by the traveler may be greater than this amount. Furthermore, in no event will Abroad for Adventure be liable for any indirect, special, incidental, consequential or other damages, however caused, whether for breach of contract, negligence or otherwise, and whether or not advised of the possibility of such damages occurring.

Video Tape/Photographic Release - The traveler agrees that Abroad for Adventure and its agents may take photographs and videotapes of the traveler and use them in promotional, publicity, merchandising or commercial purposes. The traveler hereby authorizes the reproduction, copyright, sales, broadcast and/or distribution, of said videotape, sound recording and pictures for such purposes and for no financial or other remuneration. The traveler releases Abroad for Adventure and its representatives and agents from any damages, losses, liabilities, costs, expenses or claims arising from such use of the traveler's pictures or voice.

Right to Remove Disruptive Traveler. Abroad for Adventure reserves the right to evict travelers due to excessive disturbance of others, illegal activities, material damage to property, actions that threaten the safety of the fellow travelers or any other similar activities in the judgment of Abroad for Adventure personnel. If for any reason you are evicted, you will forfeit all amounts paid (there will be no refund) and you will be responsible for the arrangement and expense of your transportation home or your lodging and meals until the pre-arranged

transportation home. Abroad for Adventure strives to provide a safe, comfortable and relaxing environment for all of its travelers. For this reason, we will enforce the strict no disturbance policy outlined above.

Governing Law and Choice of Forum. The validity and interpretation of this agreement shall be construed in accordance with, and governed by the internal laws of, the Commonwealth of Pennsylvania. All claims, disputes or causes of action relating to, in connection with or arising out of this reservation, the trip or this agreement shall be brought, heard and resolved solely and exclusively by and in a federal or state court situated in Philadelphia, Pennsylvania and the traveler agrees to submit to the jurisdiction of such courts.

CANCELLATION POLICIES

All cancellations MUST be made in writing. In the event that a traveler must cancel a trip, cancellation fees will apply, based upon the actual date written cancellation is received. Cancellation fees are determined as follows:

- 91 Days or more: \$50.00 per person
- 61 Days to 90 Days: 25% of Trip Price
- 31 Days to 60 Days: 50% of Trip Price
- 30 Days or Less: No Refund, No exceptions

Cancellation by Abroad for Adventure. We reserve the right to cancel or alter any trip due to insufficient sign-up, weather, unsafe conditions, travel provider problems or cancellations or any other circumstances. In the unfortunate event that we cancel a trip, we will make every effort when possible to notify you at least 30 days in advance. In the event of a trip cancellation, you will receive a full refund of all payments made, releasing Abroad for Adventure from further settlement and liability. Abroad for Adventure is not responsible for any expenses incurred by the traveler in preparation for a cancelled trip, such as travel document fees and non-refundable airline tickets.

TRAVEL AND TRIP CANCELLATION INSURANCE

Abroad for Adventure strongly recommends that the traveler purchase travel insurance and trip cancellation insurance. Travel Insurance is not included in any trip or weekend event price.
